PERFORMANCE LICENSE INSTRUCTIONS

ASCAP, and BMI, represent the owners of virtually all copyrighted music in the U.S.A. (Countries other than the U.S.A. should check for local regulations as copyright laws vary from country to country and the methods of meeting requirements may vary also.) The purpose of these organizations is to protect the rights of composers and authors and to insure that they receive fair compensation for the performance of their works. Sweet Adelines International serves as the clearinghouse for the collection of license fees and issues the license certificates to the chapters. When applying for a license, submit the following information:

- 1. Chapter name, chapter number, region number
- 2. Region name (if this is a request for a regional event)
- 3. Date of performance (competition)
- 4. Name of facility
- 5. Location of facility (city and state)
- 6. ASCAP rate calculation based on seating capacity & gross revenue (minimum fee is \$25.00)
- 7. BMI rate based on seating capacity only (minimum \$20.00)
- 8. Enter total enclosed and member information for the person who is to receive the license

Note: A separate license must be purchased for each performance, e.g., matinee and evening shows on the same day require two applications.
